**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release") is made as of December 5, 2022, by ALTER DOMUS (US) LLC, a Delaware limited liability company, in its capacity as administrative agent (the "Administrative Agent"), for the benefit of VORTEQ COIL FINISHERS, LLC, a Delaware limited liability company (the "Grantor"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Administrative Agent and the Grantor are parties to that certain Security and Pledge Agreement, dated as of November 30, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to (a) the Security Agreement and (b) that certain Notice of Grant of Security Interest in Trademarks, dated as of November 30, 2021 (the "Trademark Security Agreement"), the Grantor granted to Administrative Agent for the benefit of the Secured Parties, among other collateral as set forth therein, a continuing security interest (the "Security Interest") in all of the Grantor's right, title and interest in the trademarks and trademark applications set forth on Schedule I hereto (the "Intellectual Property Collateral"), to secure payment, performance and observance of the Secured Obligations;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office at Reel 7513 and Frame 0252 on December 1, 2021;

WHEREAS, the Grantor has requested that the Administrative Agent terminate and release, and the Administrative Agent is willing to terminate and release the entirety of, subject to the terms hereof, its Security Interest in the Intellectual Property Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Termination and Release. The Administrative Agent hereby terminates the Trademark Security Agreement and hereby terminates, releases and discharges its Security Interest in all of the Intellectual Property Collateral, including the trademarks and trademark applications listed on Schedule A attached hereto, and reassigns and transfers to the Grantor all right, title and interest that the Administrative Agent may have in the Intellectual Property Collateral.

2. Further Assurances. The Administrative Agent hereby agrees to duly execute and deliver to the Grantor any further documents and to do such other acts that the Grantor (or their respective agents or designees) reasonably request, in order to confirm this Termination and Release and the Grantor's right, title and interest in the Intellectual Property Collateral.

3. Governing Law. THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY OR DISPUTE ARISING UNDER OR RELATED TO THIS TERMINATION AND RELEASE OR THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.
