**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, in order to induce the Lenders under the Credit Agreement (as defined below) to make extensions of credit to, among others, Independent Pet Partners Intermediate Holdings, LLC, and certain of its subsidiaries, including IPP-STORES, LLC, WHOLE PET CENTRAL, LLC, PET LIFE, LLC, ESPECIALLY FOR PETS, LLC, PET SOURCE, LLC and NATURAL PAWZ, LLC, each a Delaware limited liability company with its chief executive office at 8450 City Centre Dr, Woodbury, MN 55125 (each a “Grantor” and, together, the “Grantors”) pursuant to (i) the Senior Secured Superpriority Priming Debtor In Possession Credit Agreement, dated as of February 5, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among Independent Pet Partners Intermediate Holdings II, LLC, a Delaware limited liability company, as Parent, Independent Pet Partners Intermediate Holdings, LLC, a Delaware limited liability company, as Borrower, the other Loan Parties from time to time party thereto, the Lenders (as defined therein), and Acquiom Agency Services LLC, a national banking association, with an office at 150 South 5<sup>th</sup> Street, Suite 2600, Minneapolis, MN 55402, as administrative agent and collateral agent for the Lenders (in such capacity, the “Agent”), and (ii) the Security Agreement, dated as of February 13, 2023, executed and delivered by, among others, each Grantor in favor of the Agent in connection with the Credit Agreement (as amended, restated supplemented or otherwise modified from time to time, the “Security Agreement”) under which each Grantor pledged and granted to Acquiom Agency Services LLC, as Agent, a continuing security interest in all of each Grantor’s Intellectual Property. Unless otherwise defined herein or the context otherwise requires, terms used herein have the meanings provided or provided by reference in the Credit Agreement and the Security Agreement (as applicable).

Each Grantor hereby pledges and grants a continuing security interest in, to and under all of each Grantor’s right, title and interest in all of the following, whether now owned or existing or at any time hereafter acquired or arising, for the benefit of the Credit Parties to secure the payment, performance and observance of the Secured Obligations:

(a) each United States Trademark (including, without limitation, those items set forth on Schedule A attached hereto), all goodwill associated therewith, and all rights to sue at law or in equity for any past, present and future infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom;

(b) all books, records, and information pertaining to each United States Trademark, and all rights of access to such books, records, and information; and

(c) to the extent not otherwise included, all Proceeds, Supporting Obligations and products of, and all income, royalties and other payments now or hereafter due and payable with respect to, any and all of the foregoing and all collateral security, liens, guarantees, rights, remedies and privileges given by any Person with respect to any of the foregoing,

provided, notwithstanding anything to the contrary contained in clauses (a) to (c) above, the security interest created by this agreement shall not extend to any United States intent-to-use

trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law, provided that upon submission and acceptance by the United States Patent and Trademark Office of an amendment to allege use pursuant to 15 U.S.C. Section 1060(a) (or any successor provision), such intent-to-use trademark application shall be considered a United States Trademark.


This grant of security interest in United States Trademarks (this "Grant") has been executed and delivered by the Grantors for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The Grantors authorize and request that the Commissioner for Trademarks record this Grant. The security interest granted hereby has been granted to the Agent for the benefit of the Credit Parties in connection with the Security Agreement and is expressly subject to the terms and conditions thereof. The rights and remedies of the Agent with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which shall be deemed to be an original, but all of which when taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Grant by telecopier, facsimile or other electronic means shall be effective as delivery of a manually executed counterpart of this Grant.
