Declaration to Correct Typographical Error in Recorded Assignment Document

I, Danica Acosta, submit this Declaration on behalf of Walmart Apollo, LLC ("the Assignee"), in my capacity as Assistant Secretary. I submit that I have firsthand knowledge of the facts set forth herein.

The Assignee declares the following:

1. The trademark assignment dated January 31, 2018 to transfer ownership of various trademarks from Wal-Mart Stores, Inc. to Walmart Apollo, LLC ("the Assignment") contained an error located within Schedule A.
2. Schedule A incorrectly lists the Registration Number of the mark MEMBER'S MARK in International Class 05 (U.S. Serial No. 86/861,775) as "5393938" ("the error"). The correct Registration Number for this filing is 5396938.
3. The incorrect Registration Number of the mark MEMBER'S MARK in International Class 05 (U.S. Serial No. 86/861,775) was also submitted on the cover sheet associated with the recordation.
4. The trademark assignment containing the error on Schedule A and the incorrect cover sheet was filed with the USPTO Assignment Recordation Branch and subsequently recorded on March 16, 2018 under Reel/Frame Number 6293/0033.
5. The Assignee desires to correct Reel/Frame 6293/0033 to reflect that Registration Number 5396938, not Registration 5393938, was transferred to Walmart Apollo, LLC.
6. The Assignee also desires to remove the references to Reel/Frame 6293/0033 from the record of Registration No. 5393938, currently owned by Going Global Educational Collaborative LLC.

The Assignee respectfully submits this Declaration along with a new Cover Sheet to record the Assignment against the corrected Registration Number 5396938. The Assignee also submits a copy of the originally recorded document containing the correction, which I have personally initiated and dated.

WHEREAS, the Intercompany Agreement and this Assignment also include the rights granted to Assignee to, with Assignor, take any action necessary, reasonable or appropriate to protect and defend the Trademarks, and if necessary, pursue any infringements of the Trademarks; and

WHEREAS, pursuant to the terms of the Intercompany Agreement and this Assignment, the Assignor has agreed to assign the Trademarks to the Assignee, and the Assignee hereby accepts said assignment;

NOW THEREFORE, for good and valuable consideration, the full receipt and full sufficiency of which is hereby acknowledged by Assignor and Assignee, the Assignor and the Assignee hereby agree as follows:

1. Assignment. Assignor hereby assigns to Assignee, and Assignee hereby accepts, the assignment and ownership of the full right and title to and in the Trademarks, together with the

goodwill of the business concerned in the goods and services for which the Trademarks are used, registered and/or identified in any pending applications assigned herewith.

2. **Further Actions.** Assignor and Assignee each agree to take any further steps necessary and appropriate to confirm and fully effectuate the assignment of the Trademarks from Assignor to Assignee.

3. **Right to Record.** Assignee and Assignor each agree that this Assignment may be recorded with the appropriate intellectual property office and/or governmental entities or agencies as may be necessary and appropriate to fully effectuate Assignor's assignment of the Trademarks to Assignee.

4. **Right to Defend and Enforce.** This Assignment includes the rights to Assignee, together with Assignor, as may be necessary and/or appropriate, to take any and all actions necessary to defend, protect and enforce Assignee's rights and ownership in and to the Trademarks.





