NUNC PRO TUNC TRADEMARK ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment ("Assignment") is made of record by and between Yulia Akulova, an individual and U.S. Citizen, with an address of 16850 Collins Avenue #112202, Sunny Isles Beach, Florida, 33160 ("Assignor") and Illuminated Goods LLC, a South Carolina limited liability company, with a business address of 2058 Carolina Place Drive, Fort Mill, South Carolina, 29708 ("Assignee").

RECITALS

WHEREAS, Assignor is the last listed owners of the following federal trademark registration:

1. CANDLEOLOGY (U.S. Registration No. 6123202)

WHEREAS, pursuant to the terms of an Asset Purchase Agreement effective February 9, 2023 (the "Agreement"), the Assignor assigned to Assignee all of its rights, titles, goodwill and interest in the CANDLEOLOGY mark and the associated Registration (collectively referred to hereafter as the "Trademark"), together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark, along with the right to recover for damages and profits for past infringements thereof; and

WHEREAS, the Assignor and the Assignee wish to evidence the Agreement by executing this instrument;

NOW THEREFORE, for the good and valuable consideration in the Agreement, the receipt and sufficiency of which is acknowledged and in consideration of the foregoing recitals and mutual promises contained herein, Assignor and Assignee hereby evidence the Agreement as follows:


1. Assignment. Assignor does hereby assign and transfer to Assignee: (1) all the property, right, title and interest in and to the Trademark including all common law rights connected therein together with the Applications and Registrations therefor for the United States and throughout the world together with the goodwill of the business in connection with which the Trademark is used and which is symbolized by the Trademark; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademark; and (3) all rights to sue for past, present and future infringements or misappropriations of the Trademark.
2. Acceptance. Assignee hereby acknowledges that it accepted the foregoing assignment for the good and valuable consideration in the Agreement on February 9, 2023, and wishes to evidence this assignment by executing this instrument.


