TRADEMARK ASSIGNMENT

WHEREAS Smogbuster Inc. AND the Assignor hereby undertakes, without further consideration, to execute all such documents and do all such acts as may be reasonably necessary to perfect this assignment and to effect recordal and registration of same at the Canadian Intellectual Property Office and the United States Patent and Trademark Office.




