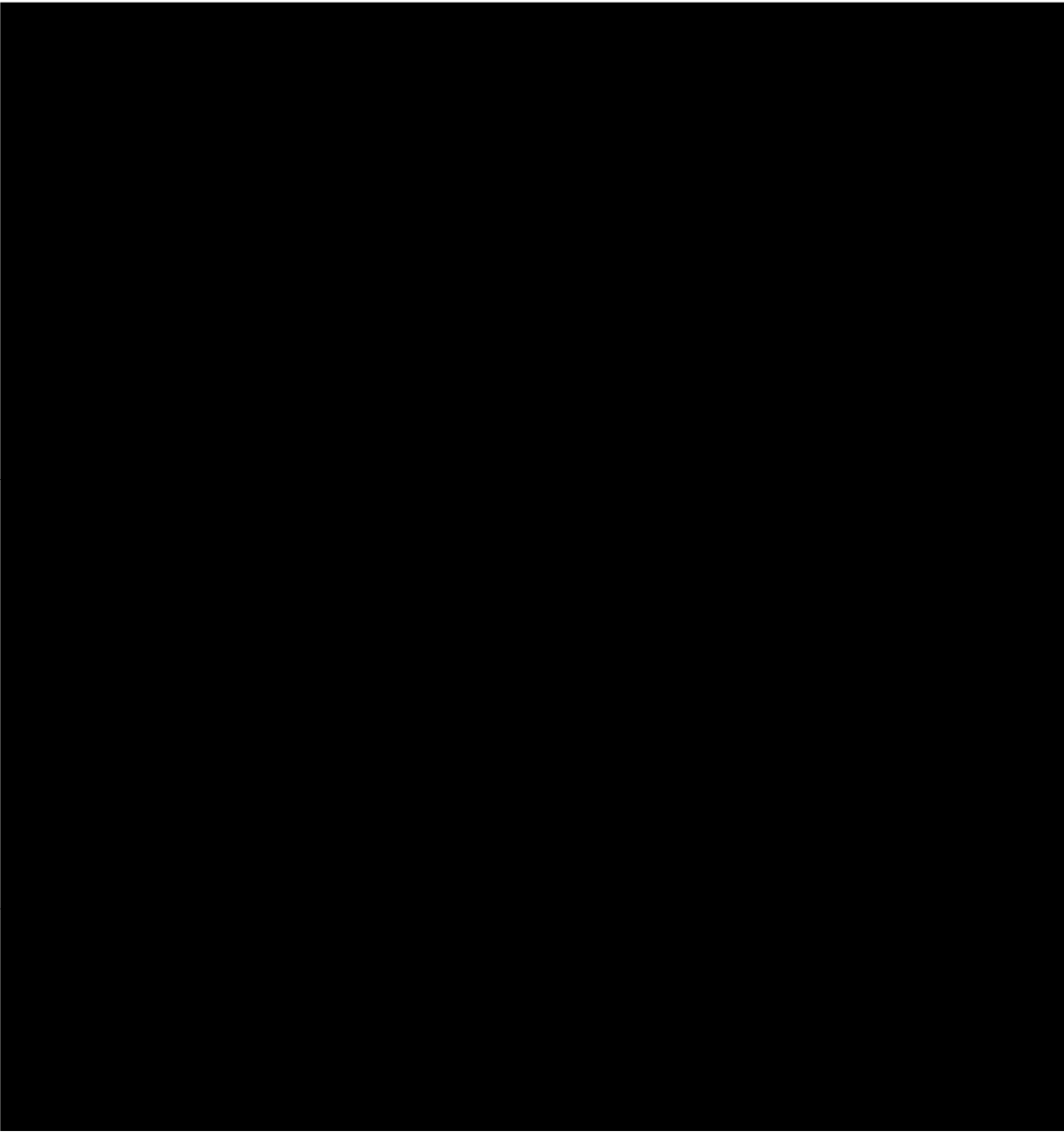


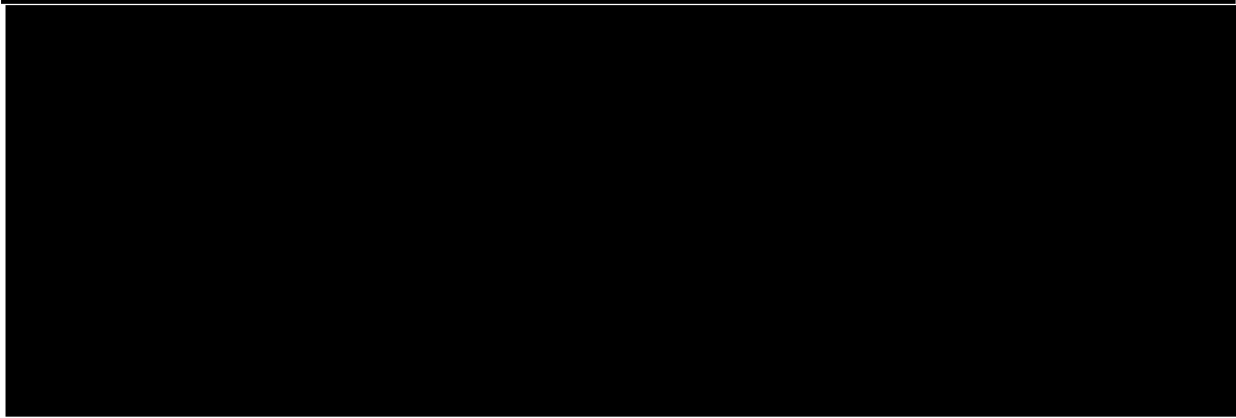
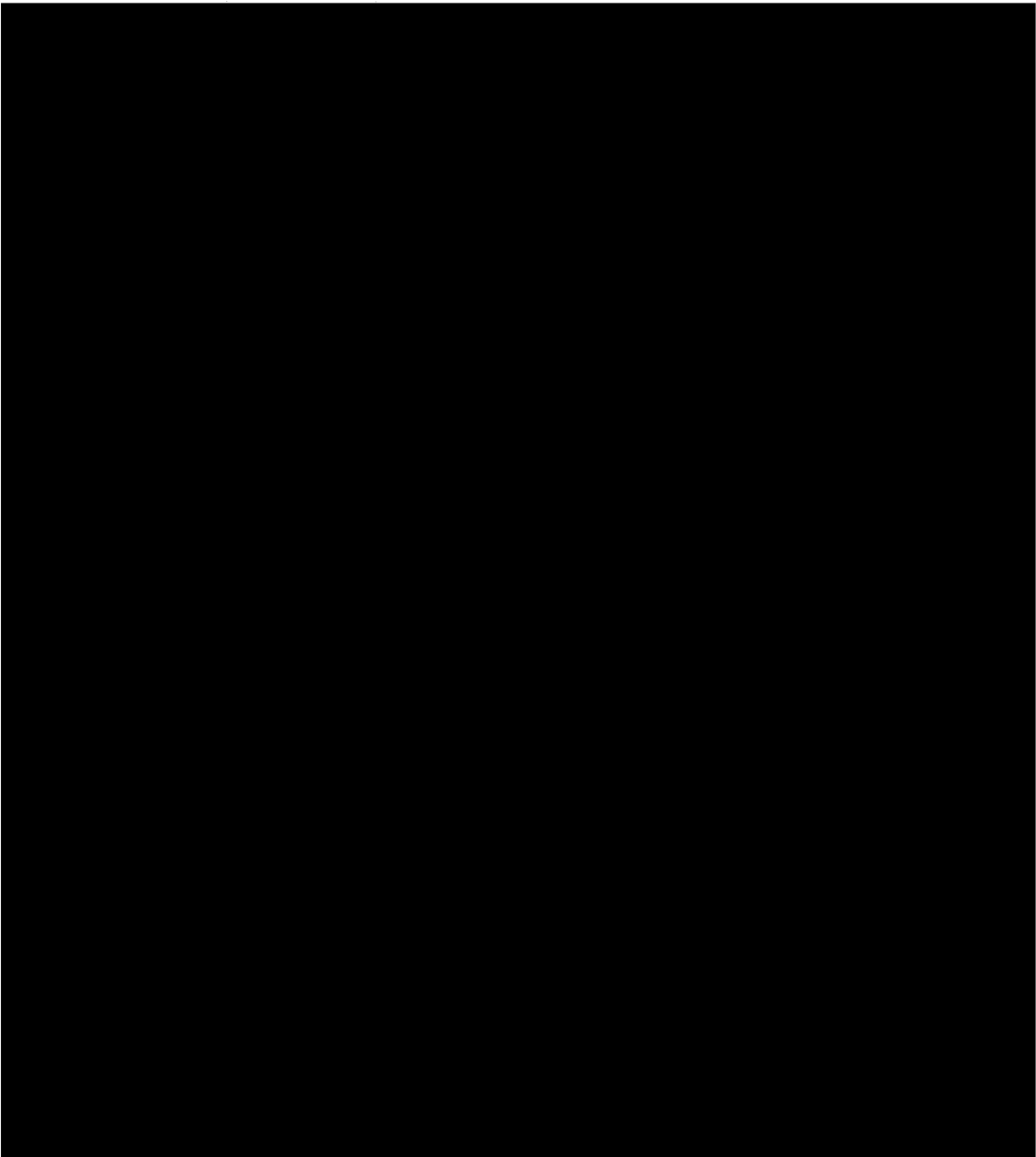


**2. ASSIGNMENT**

- 2.1.3 for the remainder of the term during which the rights and any renewals or extensions of them subsist.







