This Assignment may be executed in any number of counterparts and the parties to it on separate counterparts and each such counterpart shall constitute an original of this Assignment but all of which together constitute one and the same instrument. This Assignment shall not be effective until each party has executed at least one counterpart.
4. If at any time one or more of the provisions of this Assignment is or becomes invalid, illegal, or unenforceable in whole or in part under any law or regulation, this does not affect or impair the validity, legality or enforceability of the remaining parts or provisions of this Assignment.
