
IT IS HEREBY covenanted that Assignor has full right to convey the entire interest in the IP and Registrations herein assigned, and that Assignor has not executed and will not execute any agreement in conflict herewith, and Assignor further covenants and agrees that it will each time request is made and without undue delay, execute and deliver all such papers as may be necessary or desirable to perfect the title to said IP and Registrations in said assignee, its successors, assigns, nominees, or legal representatives, and Assignor agrees to communicate to said Assignee or to its nominee all known facts respecting said IP and Registrations, to testify in any legal proceedings, to sign all lawful papers to execute all disclaimers and divisional, continuing, reissue and foreign applications, to make all rightful oaths, and generally to do everything possible to aid said Assignee, its successors, assigns, nominees and legal representatives to obtain and enforce for its or their own benefit proper protection for said Work in any and all countries, all at the expense, however, of said Assignee, its successors, assigns, nominees or legal representatives.

AND Assignor hereby authorizes and requests the IP Registers and any official of any country or countries, including United Kingdom and United States, whose duty it is to issue copyrights, trademarks, patents, designs and all other intellectual property and industrial property registrations on applications as aforesaid, to issue and/or record to said Assignee, as assignee of the entire right, title and interest, any and all rights for those IP which may be issued and granted on or as a result of any applications included in said IP, in accordance with the terms of this assignment.
