## DEED OF ASSIGNMENT

Dated the 23 day of February 2022

This Assignment is made between:

- (1) Kane International Limited (UK Company No. 1555423) with an address at Kane House, 11 Bessemer Road, Welwyn Garden City, Hertfordshire, AL7 1GF [and formerly at Kane House, Swallowfield, Welwyn Garden City, Hertfordshire, AL7 1JG, UK ] ("the **ASSIGNOR**"); and
- (2) Kane Group Limited (UK Company No. 2647818) with an address at Hartfield Place, 40-44 High Street, Northwood, Middlesex, HA6 1BN ("the **ASSIGNEE**").

### WHEREAS

- (A) The **ASSIGNOR** is the owner of the trade mark applications and registrations which are set out in the Schedule below ("the Trade Marks").
- (B) The **ASSIGNOR** has agreed to assign to the **ASSIGNEE** the Trade Marks, together with all the goodwill attributable to the Trade Marks in the business of the **ASSIGNOR** in respect of the goods and services for which the Trade Marks have been used, upon the following terms and conditions:

**NOW THEREFORE** it is agreed that

### 1. ASSIGNMENT

Pursuant to the aforesaid agreement, and in consideration of the sum of £1.00 the receipt and sufficiency of which is hereby acknowledged, the **ASSIGNOR** hereby assigns to the **ASSIGNEE**, with full title guarantee, all rights, title and interest in the Trade Marks, and the full and exclusive benefit thereof, including all accrued rights to sue for past infringements and to receive any remedies therefor, together with all the goodwill attributable to the Trade Marks in the business of the **ASSIGNOR** in respect of the goods and services for which Trade Marks have been used, to hold the same unto the **ASSIGNEE** absolutely.

### 2. ASSIGNOR'S OBLIGATIONS AND WARRANTIES

#### 2.1 The **ASSIGNOR** undertakes that

- 2.1.1 it will promptly at the discretion and expense of the **ASSIGNEE** execute any document and do all such acts as the **ASSIGNEE** may require to enable the **ASSIGNEE** to become registered as proprietor of the Trade Marks, and to secure the benefits of the rights hereby assigned;
- 2.1.2 it will not anywhere do any act, nor assist any other party to do any act, which would or might put the validity of the **ASSIGNEE'S** title to the Trade Marks or the validity of the Trade Marks themselves at issue.

#### 2.2 The **ASSIGNOR** warrants that
