Costin A. Tuculescu and Constantin Tuculescu hereby certify as follows:

1. They are the President and the Secretary, respectively, of CosNet, Inc., a California corporation (the "Corporation").
2. Article I of the Second Amended and Restated Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

"ARTICLE I

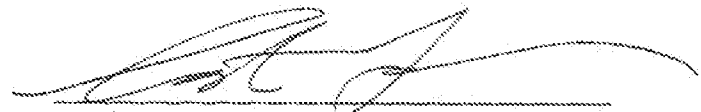
The name of this Corporation is AnyMeeting, Inc."

3. The foregoing amendment of the Second Amended and Restated Articles of Incorporation of the Corporation has been duly approved by the board of directors of the Corporation.

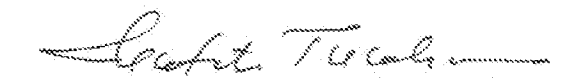
4. The foregoing amendment of the Second Amended and Restated Articles of Incorporation of the Corporation was approved by the required vote of shareholders in accordance with Sections 902 and 903 of the California General Corporation Law. The Corporation has two series or classes of shares outstanding which are entitled to vote with respect to this Amendment. On the record date for such approval this Corporation had outstanding 8,000,000 shares of Common Stock and 2,543,862 shares of Series A Preferred Stock. The percentage vote required for approval was (i) more than 50% of the aggregate number of all outstanding shares of the Common Stock and Series A Preferred Stock, voting together as a single class, and (ii) more than 50% of the aggregate number of all outstanding shares of the Series A Preferred Stock, voting separately as its own class. The number of shares of the Common Stock and Series A Preferred Stock, voting together as a single class, and of the Series A Preferred Stock, voting separately as its own class, that voted in favor of the amendment equaled or exceeded the vote required for approval.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
