**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT, is made as of February 28, 2023, by BMO Harris Bank N.A., in its capacity as Administrative Agent for itself and the other Loan Parties (together with its successors and assigns in such capacity, "Grantee"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, by Best Lockers, LLC, a Delaware limited liability company (the "Grantor") and Grantee were parties to that certain Trademark Security Agreement, dated as of February 24, 2021 (the "Trademark Security Agreement"), pursuant to which the Grantor granted a security interest to Grantee in certain Trademarks and Collateral (as defined below) to secure the payment, performance and observance of the Secured Obligations, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on February 26, 2021 at Reel 7237, Frame 0781;

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all right, title and interest of the Grantor in, to and under the Trademarks, together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral").


