**ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT**

This **ASSIGNMENT OF TRADEMARK SECURITY AGREEMENT** (this “Assignment”), dated as of April 29, 2022, is by **MACQUARIE CAF MANAGEMENT LLC**, a Delaware limited liability company, acting in its capacity as the current and resigning collateral agent (in such capacities, the “Retiring Agent”) and **MACQUARIE PF INC.**, a Delaware corporation, acting in its capacity as the successor collateral agent (in such capacities, collectively, the “Successor Agent”).

**RECITALS:**

**WHEREAS**, **CURRENT PUBLISHING CORP.**, **DIVING SCIENCE & TECHNOLOGY CORP.**, **EMERGENCY FIRST RESPONSE CORP.**, **PADI AMERICAS, INC.** and **PADI WORLDWIDE CORP.** as grantors (collectively, the “Grantors”), entered into that certain Grant of Security Interest in Trademark Rights, dated April 26, 2017, filed with the United States Patent and Trademark Office on April 26, 2017 at Reel 6044, Frame 0137, as amended by that certain Amendment No. 1 to Grant of Security Interest in Trademark Rights, dated as of August 24, 2020, filed with the United States Patent and Trademark Office on August 24, 2020, at Reel 7032, Frame 0543, (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “Agreement”) covering certain intellectual property set forth on Exhibit A attached hereto; and

**WHEREAS**, pursuant to that certain Fifth Amendment to Credit Agreement, dated as of the date hereof, by and among, *inter alios*, Retiring Agent, Successor Agent, the lenders party thereto and the Grantors, Retiring Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacity as administrative agent.

**NOW, THEREFORE**, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Retiring Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreement.

This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.




