Nunc Pro Tunc Trademark Assignment

This TRADEMARK ASSIGNMENT (“Assignment”) is made and entered into this 13 day of March, 2023, between **Spectrum Home Services Franchising LLC** (“Assignor”) and **Spectrum Home Services** (“Assignee”), a Nevada corporation.

WHEREAS, Assignor is the owner of U.S. Trademark Registration No. 3,031,598 (the “598 Registration”) for the mark SPECTRUM HOME SERVICES and Design for use in connection with “cleaning of residential houses and providing laundry services for clothing and linens, snow removal, building construction services as general contractors, structural maintenance of buildings, and house repair services; lawn care services and ground maintenance services, namely, grass cutting, tree removal, hedge trimming and planting”.

WHEREAS, Registration No. 3,031,598 was previously assigned to SHS Franchising, LLC by K&N Franchising, LLC. The assignment was executed on August 9, 2006 and recorded in the U.S. Patent and Trademark Office on August 31, 2010 (Reel 4270, Frame 0314). Registration No. 3,031,598 was then assigned to Spectrum Home Services Franchising LLC. The assignment was executed on November 16, 2015 and recorded in the U.S. Patent and Trademark Office on April 21, 2016 (Reel 5775, Frame 0370).

WHEREAS, Assignor is also the owner of U.S. Trademark Registration No. 5,159,276 (the “276 Registration”) for mark SPECTRUM HOME SERVICES used in connection with “snow removal, building construction services as general contractors, structural maintenance of buildings, and house repair services; lawn care services and ground maintenance services, namely, grass cutting, tree removal, hedge trimming and planting”.

WHEREAS, Assignee is desirous of acquiring both marks in the ‘598 Registration and the ‘276 Registration, together with the goodwill of the business symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns, *nunc pro tunc*, to the Assignee all of the right, title, and interest in and to both aforesaid marks together with the goodwill of the business connected with the use of and symbolized by said marks, effective as of September 1, 2020. It is agreed that the Assignor shall be legally bound upon request from Assignee to execute all instruments properly which Assignee may deem necessary or desirable for securing and maintaining the marks hereby assigned, all without further compensation to Assignor.

The undersigned warrants that the rights and property herein conveyed are free and clear of any encumbrance.
