

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "<u>Termination</u>") dated as of March 14, 2023, is made by Alter Domus (US) LLC, as Collateral Agent (the "<u>Secured Party</u>"), in favor of BioArray Solutions Ltd, a Delaware corporation, Immucor GTI Diagnostics, Inc., a Wisconsin corporation, Immucor Transplant Diagnostics, Inc., a Delaware corporation, Immucor, Inc. a Georgia corporation, and Sirona Genomics, Inc., a Delaware corporation (collectively, "<u>Grantors</u>").

- 3. <u>Governing Law.</u> This Termination and the rights and obligations of the parties under this Termination shall be construed in accordance with and governed by the laws of the State of New York.

The Secured Party shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantors, at Grantors' cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
