**TERMINATION AND RELEASE OF
TRADEMARKS**

THIS TERMINATION AND RELEASE OF TRADEMARKS (“Release”) is made as of March 21, 2023, by MIDTOWN MADISON MANAGEMENT LLC (as successor to Elm Park Capital Management, LLC), a Delaware limited liability company, as administrative agent for the Lenders and as collateral agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacity, “Agent”, and together with the lenders, the “Lender Group”), in favor of SCIFORMA CORPORATION, a Delaware corporation (the “Grantor”).

WHEREAS, the Grantor entered into a certain Trademark Security Agreement with Agent, dated April 1, 2021 (the “Trademark Security Agreement”), notice of which was recorded with the United States Patent and Trademark Office on April 2, 2021, at reel/frame 007249/0894. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the Trademark Security Agreement, a security interest in favor of Agent, in and to all of its right, title and interest in and to the Collateral, including the Trademarks Collateral, which include without limitation the trademarks and corresponding registrations and applications listed in Schedule 1.

WHEREAS, Agent has agreed to terminate and release all of its security interests and liens in all such Trademark Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges all of its security interests and Liens in the Trademarks Collateral, which include the trademarks, registrations and applications listed on the schedules attached hereto and made a part hereof, and assigns, transfers and conveys to Grantor any interest in such Trademarks Collateral, including the security interests.


