RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 15th day of October 2021, by Cortland Capital Market Services LLC, in its capacity as collateral agent for the Loan Parties (as such term is defined in the Security Agreement), whose address is 225 W. Washington St., 9th Floor, Chicago, IL 60606 ("Secured Party").

WHEREAS, reference is made to a certain Intellectual Property Security Agreement dated as of July 31, 2015, by and between The Rockport Company, LLC, a Delaware limited liability company (the "Debtor"), whose address is 1200 Washington Street, West Newton, MA 02465, and Secured Party (the "Security Agreement"; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement) and recorded (i) on November 2, 2015 with the Trademark Assignments Division of the United States Patent and Trademark Office ("USPTO") at Reel and Frame Number 005658/0263, (ii) on November 2, 2015 with the Patent Division of the USPTO at Reel and Frame Number 037021/0327 and (i) on November 6, 2015 with the United States Copyright Office at Volume and Document Number V9922/D314; and

WHEREAS, under the Security Agreement, Debtor granted Secured Party a security interest in all of the right, title and interest of Grantor in and under the intellectual property collateral identified therein (the "Collateral").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby irrevocably and forever releases and terminates its security interest, if any, in and to the Collateral arising thereunder including, without limitation, the intellectual property described on Schedule I, Schedule II and Schedule III attached hereto and incorporated therein by this reference, together with any and all goodwill associated therewith. Further, Secured Party understands and agrees that this Release may be recorded by or for Debtor with the USPTO, United States Copyright Office and any other similar office or agency throughout the world.


Secured Party, at no cost or expense to Secured Party, also agrees to execute any other documents and take any further action in any jurisdiction that Debtor may reasonably require to effect the intent and purpose of this Release.

This Release may be executed by one or more of the parties to this Release on any number of separate counterparts (including by .pdf, facsimile or other electronic signatures), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
