**THIRD:** The name of the surviving corporation is Lincolnshire Prolific Partners Acquisition Corp., a Delaware corporation.

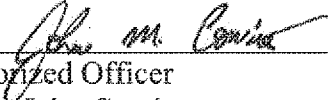
**FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.
