PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK

This **PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK** (“Partial Release”) is made as of March 31, 2023 (“Effective Date”) executed by Capital One, National Association, in its capacity as agent (“Agent”) in favor of Acumen Health Holdings, LLC, a Delaware limited liability company (the “Grantor”). Capitalized terms used herein without definition shall have the meanings assigned to them in the Credit Agreement (defined below).

WHEREAS, pursuant to the terms and conditions of that certain Credit Agreement, dated as of August 31, 2021 (as the same may be amended, modified, extended or restated from time to time, the “Credit Agreement”), the Grantor granted to Agent, pursuant to the Guaranty and Security Agreement, dated as of August 31, 2021 in favor of the Agent a Lien on and security interest in, all of its right, title and interest in the trademarks and trademark licenses, registrations and recordings thereof, and all applications in connection therewith; all goodwill associated therewith or symbolized thereby (collectively the “Trademark Collateral”);

WHEREAS, the Grantor executed and delivered that certain Trademark Security Agreement, dated as of August 31, 2021 in favor of the Agent (the “Trademark Agreement”) to evidence the Agent’s security interest in and Lien on the Trademarks;

WHEREAS, the Trademark Agreement was recorded with the United States Patent and Trademark Office on August 31, 2021 at Reel 7409 Frame 0282;

WHEREAS, the Agent wishes to release all of its right, title and interest in and dissolve those Liens and encumbrances created by the Trademark Agreement solely with respect to the specific trademark set forth on Schedule 1 attached hereto (the “Released Trademark”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, for itself and on behalf of the Secured Parties, hereby releases, assigns and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Released Trademark, and terminates, releases, discharges, quitclaims and relinquishes unto Grantor any and all security interests and Liens it has against the Released Trademark; and

FURTHER, the Trademark Agreement remains (following the foregoing release in respect of the Released Trademark) in full force and effect as among the Agent, the Grantor and the other Credit Parties party thereto as grantors, in respect of all continuing Trademarks.
