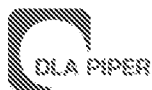

Parties

- (1) **THE COMPANIES LISTED IN Schedule 1 TO THIS DEED** (together the **Charging Companies** and each a **Charging Company**); and
- (2) **HSBC CORPORATE TRUSTEE COMPANY (UK) LIMITED** (as Security Agent for the Secured Parties (as defined by reference below)) (in such capacity, the **Security Agent**).

Background

- A The Charging Companies are parties to the Debenture (as defined below) under which it granted security over all its present and future assets as security for the Secured Obligations (as defined in the Debenture).
- B The Charging Companies enter into this Deed pursuant to clause 20 (*Further assurances*) of the Debenture in order to more effectively perfect the security created by the Debenture over the Trademarks (as defined below).

It is agreed:

1 Definitions and interpretation

1.1 Definitions

In this Deed (including the recitals to it):

- (a) terms defined in or construed for the purposes of the Debenture (as defined below) have the same meanings when used in this Deed (unless otherwise defined in this Deed); and
- (b) the following terms have the following meanings:

Debenture means the debenture dated 20 October 2021 and made between (1) the companies named in it as original chargors and (2) the Security Agent, as supplemented by a deed of accession dated 17 December 2021 pursuant to which Revolution Beauty Labs Ltd acceded as a chargor; and

Trademarks means the intellectual property rights specified in the Schedule 2 (*Details of Trademarks*).

1.2 Interpretation

- (a) Unless a contrary indication appears, any reference in this Deed to the **Charging Companies** or the **Security Agent** shall be construed so as to include its successors in title, permitted assigns and permitted transferees.
- (b) The principles of construction set out in clause 1.2 (*Interpretation*) of the Debenture shall apply to this Deed, with any necessary changes, as if they were set out in full in this Deed.

1.3 Incorporation of provisions

Clauses 1.4 (*Trust*), 1.5 (*Third party rights*) and 25 (*Notices*) of the Debenture are incorporated into this Deed, with any necessary changes and as if references in them to the "*Debenture*" or "*this Deed*" were references to this Deed, as if they were set out in full in this Deed.

2 Grant of security

2.1 Nature of security

All Security and dispositions created or made by this Deed are created or made:

- (a) in favour of the Security Agent;
- (b) with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994; and
- (c) as continuing security for payment of the Secured Obligations.

2.2 Fixed charge

Each Charging Company charges and agrees to charge by way of first fixed charge all of its present and future right, title and interest in and to the Trademarks specified in Schedule 2 (*Details of Trademarks*) of this Deed.

2.3 Application of Debenture provisions

The Security created by this Deed is created "*pursuant to the Debenture*" and:

- (a) all references in the Debenture to the **Security Assets** include the Intellectual Property and the other assets charged by this Deed, and to the **Debenture Security** includes the Security created by or pursuant to this Deed; and
- (b) all provisions of the Debenture relating to the **Security Assets** or the **Debenture Security** (including, without limitation, obligations of the Charging Companies and rights of enforcement) apply respectively to the Intellectual Property and the other assets charged by this Deed and to the Security created by this Deed.

3 Representations

3.1 General

Each Charging Company makes the representations and warranties set out in this clause 3 to the Security Agent and to each other Security Party on the date of this Deed.

3.2 Ownership of Intellectual Property

Each Charging Company is:

- (a) the sole legal and beneficial owner of all of the Trademarks identified against its name both as the "*Chargor*" and as the "*Registered Proprietor*" in Schedule 2 (*Details of Trademarks*); and
- (b) in respect of all of the Trademarks identified against its name as the "*Chargor*" but not as the "*Registered Proprietor*", it is the sole beneficial owner of all such Trademarks.

4 Undertakings

Without prejudice to clause 20 (*Further assurances*) of the Debenture, each Charging Company shall:

- (a) notify the Security Agent promptly upon (and in any event within 30 days of) its new application for, registration of and/or acquisition of any Intellectual Property which is material in the context of its business (the **New Intellectual Property**); and
- (b) promptly upon request by the Security Agent (and in any event within 30 days of such request), execute and deliver to the Security Agent a supplemental fixed charge in substantially the same form as this Deed in relation to such New Intellectual Property.

5 Supplemental Deed

5.1 Debenture

- (a) This Deed is supplemental to the Debenture.
- (b) This Deed is a Finance Document.
- (c) From the date of this Deed the provisions of the Debenture and of this Deed shall be read and construed as one and all references to the Debenture shall be deemed to incorporate the provisions and amendments contained in this Deed.

5.2 Continuance in force

For the avoidance of doubt, the provisions of the Debenture and the other Finance Documents (except as amended by this Deed) continue to apply and remain in full force and effect.

6 Counterparts

This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures (and seals, if any) on the counterparts were on a single copy of this Deed.

7 Governing law







This Deed and any non-contractual obligations arising out of or in connection with it shall be governed by English law.
