**GRANT OF SECURITY INTEREST  
IN UNITED STATES TRADEMARKS**

April 3, 2023

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Inspire Cosmetic Surgery Delray Beach, LLC, a Florida limited liability company ("Grantor"), having its principal office at 1010 S. Federal Highway, Suite 1010, Delray Beach, FL 33483, hereby grants to Acquiom Agency Services LLC, in its capacity as Agent (in such capacity, "Grantee"), having its principal office at 950 17th St, Suite 1400, Denver CO 80202, a security interest in (a) all of Grantor's right, title and interest in and to the United States trademarks set forth on Schedule A attached hereto (collectively, the "Marks", and each, a "Mark"), (b) all proceeds and products of each Mark, (c) the goodwill of the businesses with which each Mark is associated and (d) all causes of action arising prior to or after the date hereof for infringement of each Mark or unfair competition regarding the same.

THIS GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Grant") is made to secure the satisfactory performance and payment of the Obligations, as such term is defined in that certain CREDIT AGREEMENT, dated as of the date hereof (as amended, modified, restated and/or supplemented from time to time, the "Credit Agreement") among the Grantor, HH-Inspire Intermediate, Inc., a Delaware corporation ("Holdings"), HH-Inspire Acquisition, Inc., a Delaware corporation ("Inspire Acquisition"), Inspire Cosmetic Surgery Fort Lauderdale LLC, a Florida limited liability company ("Inspire FTL"), Inspire Aesthetics Management, LLC, a Florida limited liability company ("Inspire Aesthetics" and together with Grantor, Holdings, Inspire Acquisition and Inspire FTL, collectively, the "Credit Parties"), the financial institutions or other entities from time to time parties thereto, as lenders and the Agent. Upon termination of the Credit Agreement and the payment in full of the Obligations (as defined in the Credit Agreement), Grantee shall execute, acknowledge and deliver to Grantor, upon Grantor's request, an instrument in writing releasing the security interest in the Marks acquired under this Grant.

Reference is hereby made to that certain SECURITY AGREEMENT, dated as of the date hereof, by and among Credit Parties, as debtors, and Agent (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement").


