TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Termination and Release”), dated as of March 31, 2023, by SB CORPORATE FUNDING, LLC (the “Administrative Agent”).

WITNESSETH:

WHEREAS, reference is made to that certain Trademark Security Agreement, dated as of February 1, 2023, by FOUNDRY DIGITAL LLC, a Delaware limited liability company, COINDESK, INC., a Delaware corporation and LUNO GROUP HOLDINGS LIMITED, a limited company registered in England and Wales with company number 13876256 (each a “Grantor”, and collectively, the “Grantors”) in favor of Administrative Agent;

WHEREAS, each Grantor, the Administrative Agent and the other parties thereto have entered into that certain Credit Agreement, dated as of November 12, 2021 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the “Credit Agreement”).

WHEREAS, each Grantor has entered into that certain Pledge and Security Agreement, dated as of November 12, 2021 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”; terms used but not otherwise defined herein shall have the meaning given to them in the Security Agreement), in favor of the Administrative Agent;

WHEREAS, pursuant to the Trademark Security Agreement, the Credit Agreement and the Security Agreement, a lien on and security interest (the “Security Interest”) was granted by each Grantor to the Administrative Agent in certain collateral, including the trademarks and trademark applications shown on Schedule A hereto (the “Trademarks”);

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees as follows:

1. Release of Security Interest. The Administrative Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Trademarks, and any right, title or interest of the Administrative Agent in such Trademarks shall hereby cease and become void.
2. Recordation. The Administrative Agent authorizes each Grantor or its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at Borrower’s expense.


