## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of April 6, 2023 (this "Release"), is made by MONROE CAPITAL MANAGEMENT ADVISORS, LLC (in such capacity, together with its successors and assigns in such capacity, "Administrative Agent") in favor of QOGNIFY LTD., a company incorporated and existing under the laws of the State of Israel, QOGNIFY LIMITED, a company incorporated and existing under the laws of the United Kingdom, and ON-NET SURVEILLANCE SYSTEMS INC., a New York corporation (collectively, "Grantors").

### WITNESSETH

WHEREAS, Grantors and Administrative Agent are parties to that certain Amended and Restated Guaranty and Collateral Agreement, dated as of December 28, 2018 (as amended, supplemented or otherwise modified from time to time, the "Guaranty and Collateral Agreement");

WHEREAS, pursuant to the Guaranty and Collateral Agreement, Grantors executed the U.S. Trademark Security Agreement, dated as of December 28, 2018 (the "Agreement") and recorded with the U.S. Patent and Trademark Office on December 28, 2018 at Reel/Frame No. 6511/0322, pursuant to which Grantors pledged and granted to Administrative Agent a continuing security interest in all of Grantors' right, title and interest in, to and under the Trademark Collateral (as defined in the Agreement).

WHEREAS, Grantors have requested that Administrative Agent release its security interest in and to all of its right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to Grantors, without recourse, representation or warranty, any and all right, title and interest that Administrative Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Collateral Agreement and the Agreement.
