**AMENDMENT NO. 1 TO THE
CERTIFICATE OF INCORPORATION
OF

(Pursuant to Section 242 of the General Corporation Law of the State of Delaware)

BCR Leona Holdings Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "General Corporation Law"),

DOES HEREBY CERTIFY:

FIRST: The name of the corporation is BCR Leona Holdings Inc. (the "Corporation") and that the Corporation was originally incorporated pursuant to the General Corporation Law on February 7, 2020 under the name BCR Leona Holdings Inc.

SECOND: The Certificate of Incorporation of the Corporation is hereby amended by striking Article First thereof and by substituting in lieu of said Article the following new Article:
