RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS

This RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (the “Release”), dated as of April 6, 2023, is made by JPMORGAN CHASE BANK, N.A., having a place of business at Middle Market Servicing, 131 South Dearborn Street, Floor 4, Chicago, IL 60603-5506, Attention: Loan and Agency Servicing (“Lender”) in favor of COGNOSANTE HOLDINGS, LLC, a Delaware Limited Liability Company, having a place of business at 3110 Fairview Park Drive, Suite 800, Falls Church, VA 22042 (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Credit Agreement or the Security Agreement (as those terms are defined below).

WHEREAS, Grantor and Lender are parties to a Security Agreement dated as of July 22, 2021 (either as amended, supplemented or otherwise modified, renewed or replaced from time to time, the “Security Agreement”);

WHEREAS, Grantor and Lender are parties to a Patent and Trademark Security Agreement dated as of July 22, 2021, recorded with the United States Patent and Trademark Office (“USPTO”) on July 28, 2021 at Reel 057011, Frame 0178 and at Reel 007367, Frame 0565 (the “Notice of Grant”);

WHEREAS, pursuant to the Security Agreement, the Grantor granted to Lender a continuing security interest in, and a right of set off against (the “Security Interest”) (i) the patents and patent applications referred to on Schedule A hereto (the “Patent Collateral”), and (ii) the trademarks and trademark applications referred to on Schedule B hereto (the “Trademark Collateral”, and together with the Patent Collateral, collectively, the “Collateral”), notice of which was provided in the USPTO pursuant to the Notice of Grant; and

WHEREAS, Lender has agreed to terminate and release the Security Interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. Lender hereby terminates, extinguishes, cancels, releases and discharges the Security Interest in the Collateral, and assigns, discharges, quit claims and relinquishes unto Grantor any and all right, title and interest it has in and to the Collateral. The Grantor, and any successor to the Grantor (including any person or entity hereafter holding any right, title or interest in and to the Collateral) is hereby authorized to record this Release in the USPTO.


2. Further Assurances. Lender shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor’s cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.
