**RELEASE OF SECURITY INTEREST
IN U.S. TRADEMARKS**

WHEREAS, the Collateral Agent now desires to terminate and release its security interest in all right, title or interest of Grantor in or to the Trademark Collateral, including, without limitation, the United States trademarks set forth on Schedule A attached hereto.

NOW, THEREFORE, the Collateral Agent, without recourse, representation or warranty of any kind or nature, hereby terminates and releases its security interest in all right, title or interest of Grantor in or to the Trademark Collateral, including, without limitation, the United States trademarks set forth on Schedule A attached hereto.


The Collateral Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.


