NOW, THEREFORE, for good and valuable consideration (including any such consideration recited in the Contribution Agreement), the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee confirm as follows:



Assignor hereby confirms that, pursuant to the Contribution Agreement, it has irrevocably assigned, transferred, and delivered to Assignee all of its right, title, and interest in and to the Marks, including those identified in Exhibit A hereto, together with the goodwill of the business symbolized by the Marks, as well as, without limitation, all registrations and applications therefor, any renewals of the registrations, all common-law rights relating thereto, and the right to bring an action at law or in equity for any infringement, dilution, or unauthorized use of the Marks prior to the Effective Date, together with the right to retain all damages, proceeds, and recoveries therefrom, and all other corresponding rights that are or may be secured under law, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns, or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties, or payments due or payable as of the Effective Date or thereafter, including without limitation all claims for damages by reason of past, present, or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representatives.
2. Assignee, for no further consideration, will take all further actions necessary to perfect and record Assignee's ownership of and title to the Marks and will bear any and all costs associated therewith.
3. Each Party hereto shall execute and deliver (or cause to be executed and delivered) such additional documents, certificates, and make (or cause to be made) any filings or notices that may be necessary or appropriate to consummate and make effective in the most expeditious manner practicable, this Confirmation and each party hereto shall take

all such further action as may be necessary or appropriate to consummate and make effective, in the most expeditious manner practicable, this Confirmation.

4. This Confirmation may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.
