Each party hereto shall, and shall cause its respective subsidiaries to, promptly execute, acknowledge and deliver any other assurances or documents or instruments of transfer or assumption reasonably requested by the other party to confirm and perfect the assignment contemplated herein.

4. Governing Law. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware, without regard to its conflicts of laws rules.


