**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (the "Termination and Release") dated as of April 21, 2023, from CERBERUS BUSINESS FINANCE AGENCY, LLC, as Administrative Agent and Collateral Agent (the "Agent") in favor of EMTEC GLOBAL SERVICES LLC, a Delaware limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of August 31, 2022, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Guarantee and Collateral Agreement"), the Grantor granted to the Agent, for the benefit of the Secured Parties, a security interest (the "Security Interest") in certain collateral, including the EMTEC GLOBAL SERVICES LLC trademarks set forth on Schedule A attached hereto and all related goodwill associated with such trademark and applications and registrations from such trademark (such trademarks set forth on Schedule A attached hereto and all related goodwill associated therewith and applications and registrations therefrom collectively, the "Trademarks");

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of August 31, 2022, among, *inter alios*, the Agent and the Grantor (the "Trademark Security Agreement"), the Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the Security Interest to the Agent specifically in certain Intellectual Property, including the Trademark set forth on Schedule A hereto;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on September 15, 2022 at Reel 7851 and Frame 0297; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks set forth on Schedule A (but not any other Trademark Collateral or other Collateral);

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement or the Security Agreement, as applicable.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest solely in the Trademarks listed on Schedule A (but not any other Trademark Collateral or other Collateral), and any right, title or interest of the Agent in such Trademark shall hereby cease and become void.
3. Counterparts. This Termination and Release may be executed in counterparts (including by telecopy or electronic (i.e., "pdf") transmission), each of which will be deemed an original, but all of which together constitute one and the same original.


