This MASTER TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is dated as of February 28, 2023, effective as of the Agreement Effective Time (as defined below), by and between Champion Petfoods LP (by its general partner, Champion Petfoods (GP) Ltd.) ("Assignor"), and CP Holdings USA, LLC ("Assignee"). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Underlying Agreement (as hereinafter defined).

WHEREAS, Assignor is the owner of all rights, title, and interest in and to the trademarks (including the registrations and applications for the trademarks) listed on Schedule A hereto, along with all other trademarks of the Assignor used, held for use or otherwise relating to the operation of the Business, whether registered or unregistered (collectively, the "Assigned Trademarks");

WHEREAS, pursuant to that certain Purchase and Sale Agreement to which Assignor and Assignee are parties, dated as of October 31, 2022 (the "Underlying Agreement"), Assignor agreed to sell, assign, transfer, convey, and deliver to Assignee, and Assignee agreed to purchase, acquire and accept from Assignor, all of Assignor's right, title and interest in and to certain assets, including the Assigned Trademarks, together with the goodwill of the business symbolized by the Assigned Trademarks; and

WHEREAS, pursuant to the execution by Assignor and Assignee of the General Conveyance, pursuant to which the Purchased Assets, including the Assigned Trademarks, are or have been transferred and assigned to Assignee, Assignor and Assignee wish to confirm and memorialize their agreement with respect to the sale, assignment, transfer conveyance and delivery of the Assigned Trademarks to Assignee under the Underlying Agreement and General Conveyance, and, through this Assignment, the parties hereto are confirming and consummating such transactions contemplated by the Underlying Agreement and General Conveyance.

NOW, THEREFORE, for and in consideration of the premises and the mutual covenants contained herein, and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, do hereby agree as follows:

1. <u>Assignment</u>. Pursuant to, and on the terms set forth in, the Underlying Agreement and General Conveyance, Assignor hereby confirms that it has sold, assigned, transferred, conveyed, delivered, and set over to Assignee, effective as of the Agreement Effective Time, all of Assignor's right, title, and interest in, to and under the Assigned Trademarks in the United States and throughout the world, including all renewals thereof and all rights of priority under international conventions and all foreign counterparts of such Assigned Trademarks and any trademark applications claiming priority thereto, and any and all trademarks issuing from any of the foregoing trademark applications, together with the goodwill of the business symbolized by the Assigned Trademarks, including all rights to sue, counterclaim, and to collect damages and payments for claims of past, present, and future infringements, unfair competition, misappropriations, damage, or injury thereof, and all profit, income, royalties, damages, and payments now or hereafter due or payable with

respect thereto, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns, or other legal representatives.

- 2. <u>Effective Time</u>. This Assignment is effective as of 12:06 a.m. (Eastern standard time) on the Closing Date (the "**Agreement Effective Time**").
- 3. <u>Further Assurances</u>. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Assignor shall provide to Assignee and its successors, assigns, or other legal representatives cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, confirmatory assignments, short-form assignments, and other documentation as may be reasonably required), at Assignee's reasonable request and expense, in connection with the implementation, perfection, and/or recording of this Assignment, including executing any other documents to effectuate the intent of this Assignment, and otherwise taking such other action as Assignee may reasonably request to more effectively consummate the assignments and assumptions contemplated by this Assignment. The parties hereto further agree that this Assignment may be recorded with the United States Patent and Trademark Office and/or other domestic/foreign government offices to confirm Assignee's ownership of the Assigned Trademarks.
- 4. <u>Amendment; Waiver</u>. This Assignment may not be amended, waived or otherwise modified except by a written instrument signed by both Assignor and Assignee.
- 5. <u>Counterparts</u>. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. The parties hereto acknowledge and agree that executed signature pages delivered by .pdf, facsimile or electronic mail shall for all purposes constitute original signature pages.
- 6. <u>Governing Law and Jurisdiction</u>. This Assignment is and shall be deemed to be a contract entered into and made pursuant to the Laws of the Province of Ontario and the Laws of Canada applicable therein and shall in all respects be governed, construed, applied and enforced in accordance with said Laws, without reference to applicable conflict of laws rules or principles.
- 7. <u>Underlying Agreement</u>. This Assignment is executed and delivered in connection with the consummation of the transactions contemplated by the Underlying Agreement. Nothing contained in this Assignment is intended to or shall be deemed to modify, expand, alter, amend, or otherwise change any of the rights or obligations of Assignee and Assignor under the Underlying Agreement. Assignor and Assignee acknowledge and agree that the terms and conditions contained in the Underlying Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Underlying Agreement and the terms hereof, the terms of the Underlying Agreement shall govern.


