TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), dated as of April 28, 2023, is made by The Governor and Company of the Bank of Ireland, in its capacity as the collateral agent for the Secured Parties (the "Collateral Agent") in favor of Trachte, LLC (the "Grantor"). Capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (defined below).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of September 16, 2020, the Grantor granted to the Collateral Agent a security interest in and to all of such Grantor's right, title and interest in and to all Owned Trademarks (the "Trademark Security Agreement"), including, but not limited to the registrations and applications referred to in Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (the "USPTO") on September 18, 2020 at Reel/Frame: 7056/0533; and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Owned Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby:

- (a) terminates, relinquishes, releases and discharges all liens and security interests granted to the Collateral Agent in the Owned Trademarks;
- (b) reassigns, transfers, and conveys to the Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Owned Trademarks;
- (c) terminates and cancels the Trademark Security Agreement; and
- (d) agrees that it shall, at the Grantor's sole cost and expense, execute all other documents and do all other acts in writing reasonably requested by the Grantor and reasonably necessary to relinquish, confirm, effectuate or record this Termination and hereby authorizes the Grantor or its designee to record this Termination with the USPTO.

This Termination shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
