**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of January 18, 2023, by **BANK OF MONTREAL**, a Canada corporation (in such capacity, together with its successors and assigns, “Collateral Agent”) in favor of **ZAPPROVED LLC**, a Delaware limited liability company with an address at 2175 NW Raleigh Street, Suite 400, Portland, Oregon 97210 (“Pledgor”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Pledgor entered into a certain trademark security agreement dated May 13, 2022 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on May 13, 2022 at the United States Patent and Trademark Office at Reel 7720, Frame 0893, such Trademark Security Agreement executed as an obligation to the underlying Credit Agreement dated contemporaneously therewith.

WHEREAS, Pledgor granted the Collateral Agent, under the terms of the Trademark Security Agreement and the related Credit Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in all of its right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Pledgor, including all of the goodwill of such Pledgor’s business symbolized by the Trademark Collateral and associated therewith, and assigns, transfers and conveys to Pledgor any interest in such intellectual property, including the Security Interest.
