**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of May 2, 2023, by **U.S. BANK NATIONAL ASSOCIATION**, as Administrative Agent (the “**Agent**”), in favor of **GOLDEN WEST FOOD GROUP, INC.**, a California corporation, **GOLDEN WEST TRADING, INC.**, a California corporation, **CALIFORNIA RANCH FOOD COMPANY, INC.**, a California corporation, **COMPLETELY FRESH FOODS, INC.**, a California corporation, **TEVA FOODS, INC.**, a California corporation, **CALIFORNIA FARMS MEAT COMPANY, INC.**, a California Corporation, **STRATUS GROUP, LLC**, a California limited liability company, **CULVER CITY MEAT CO., INC.**, a California corporation, **JERKY LLC**, a California limited liability company, **GWFGPI LLC**, a California limited liability company (collectively, the “**Grantors**” and each, individually, a “**Grantor**”).

**WHEREAS**, the Grantors executed and delivered that certain Trademark Security Agreement, dated as of May 31, 2017 (the “**TMSA**”; capitalized terms used but not otherwise defined herein shall have the meanings given to such terms in the TMSA), with reference to that certain Financing Agreement, dated as of June 28, 2012 by and among the Grantors and other Borrowers thereunder and the Agent (as amended, restated, supplemented or otherwise modified) and the other Loan Documents, granting to the Agent a continuing first priority security interest in all of their right, title and interest, whether presently existing or thereafter created or acquired, in, to and under Trademark Collateral, and the TMSA was recorded at the U.S. Patent and Trademark Office (the “**USPTO**”) on June 2, 2017 at Reel 6075 / Frame 0876.

**WHEREAS**, the Grantors have requested that the Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Trademark Collateral as herein provided; and

**WHEREAS**, the Grantors have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the TMSA and releases, terminates, cancels and discharges fully, without recourse, representation or warranty of any kind, all liens and security interests thereunder in any and all of the Grantors’ right, title and interest in, to and under the Trademark Collateral, including, without limitation, those registered trademarks and applications for such registration identified in Schedule I hereto; and
2. authorizes and requests that the Grantors or their designees record this Termination and Release with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
