**RELEASE OF TRADEMARK SECURITY AGREEMENT**

May 16, 2023

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in U.S. Trademarks, dated May 23, 2013, recorded in the United States Patent and Trademark Office at Reel 5051, Frame 0362 on June 19, 2013 (the "Trademark Security Agreement"), Heat Controller LLC, a Delaware limited liability company ("Grantor"), granted in favor of JPMorgan Chase Bank, N.A. ("Lender"), a security interest in all of the trademarks and trademark applications (the "Trademark Collateral"); and

WHEREAS, Grantor has requested and Lender has agreed to provide this Release of Trademark Security Agreement (this "Release") to confirm the release, relinquishment and discharge of its security interest in the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing, intending to be legally bound and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Lender hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Lender hereby terminates the Trademark Security Agreement and irrevocably and unconditionally terminates, releases, relinquishes, cancels and discharges the collateral pledges, grants, liens and security interests granted by Grantor in favor of Lender in and to the Trademark Collateral and all rights and interests in, to and under the Trademark Collateral, including each trademark listed on Schedule 1 hereto.
3. Authorization. Lender hereby authorizes Grantor or Grantor's agent to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.
4. Governing Law. This Release shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, excluding conflict of laws principles that would cause the application of laws of any other jurisdiction.
