RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) dated as of May 23, 2023, by JPMORGAN CHASE BANK, N.A., as Collateral Agent (the “Collateral Agent”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the ABL Guarantee and Security Agreement (as defined below).

WHEREAS, Prospect Medical Holdings, Inc., a Delaware corporation, Prospect Crozer, LLC, a Pennsylvania limited liability company, and Prospect ECHN, Inc., a Connecticut corporation (each, a “Lien Grantor” and collectively, the “Lien Grantors”) own, or in the case of licenses is a party to, the Trademark Collateral;

WHEREAS, pursuant to an ABL Guarantee and Security Agreement dated as of June 30, 2016 (as amended and/or supplemented from time to time, the “Security Agreement”) among the Lien Grantors and the Collateral Agent, each Lien Grantor has guaranteed certain obligations of the Borrower and secured such guarantee by granting to the Collateral Agent for the benefit of the Secured Parties (as defined in the Security Agreement) a continuing security interest in personal property of the Lien Grantors, including all right, title and interest of each Lien Grantor in, to and under the Trademark Collateral;

WHEREAS, pursuant to the Security Agreement, the Lien Grantors executed and delivered an ABL Trademark Security Agreement, dated as of June 30, 2016 (the “Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on July 1, 2016, at Reel 5826, Frame 0601;

WHEREAS, pursuant to the Security Agreement, the Lien Grantors executed and delivered an ABL Trademark Security Agreement, dated as of September 2, 2016 (the “Supplemental Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Supplemental Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on September 2, 2016, at Reel 5869, Frame 00736;

WHEREAS, pursuant to the Security Agreement, the Lien Grantors executed and delivered an ABL Trademark Security Agreement, dated as of January 26, 2017 (the “Second Supplemental Trademark Security Agreement”), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Second Supplemental Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on February 14, 2019, at Reel 6563, Frame 0555;

WHEREAS, each Lien Grantor has requested that the Collateral Agent release its security interest in and lien on the Trademark Collateral and all rights in the same to each Lien Grantor;

WHEREAS, each Lien Grantor has satisfied and fulfilled all of its obligations to release the Collateral Agent's security interest in and lien on the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent hereby fully releases, discharges, terminates and cancels its liens and security interest in all right, title and interest in, to and under the Trademark Collateral.

2. The Collateral Agent hereby grants and conveys to the Lien Grantors, without any representation, recourse or undertaking by the Collateral Agent, any and all of the Collateral Agent's right, title and interest in and to the Trademark Collateral and hereby terminates the Trademark Security Agreement.

3. GOVERNING LAW. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.




