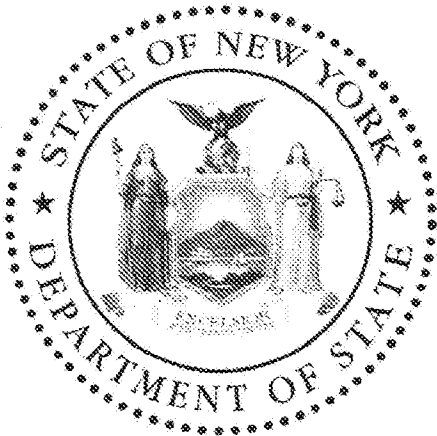

**FIRST:** The current name of the corporation is Howard L. Zimmerman, Architects & Engineers, P.C. The entity was formed under the name HOWARD L. ZIMMERMAN, ARCHITECTS, P.C.

**SECOND:** The date of filing of the certificate of incorporation with the New York State Department of State is March 3, 1998.

**THIRD:** The certificate of Incorporation was amended by a Certificate of Amendment, which was filed with the Department of State of the State of New York on August 17, 2020.

**FOURTH:** The amendments effected by this certificate of amendment are as follows:

Paragraph **FIRST** (1) of the Certificate of Incorporation relating to the name of the Corporation is hereby amended to read:

**SECOND:** The purpose for which the corporation is formed is to practice the professions of Architecture and Professional Engineering.

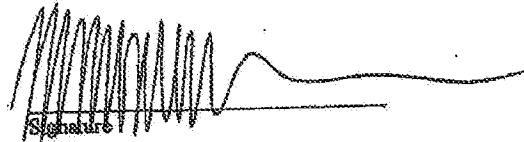
