TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Assignment"), is effective as of April 21, 2023 (the "Effective Date") and is made by and between NC SOFT CORPORATION, a South Korean corporation having a principal place of business of Samseong-dong 509 Teheran-ro, Gangnam-gu, Seoul, South Korea, 13494 (the "Assignor"), and NC DINOS BASEBALL COMPANY, a South Korean company with a principal place of business of 63, Samho-ro, Masanhoewon-gu, Changwon-si, Gyeongsangnam-do, Republic of Korea (the "Assignee")(collectively, the Assignor and the Assignee are referred to as the "Parties").

WHEREAS, Assignor is the owner of the trademark NC DINOS and the goodwill of the business symbolized thereby and associated therewith (the "Mark");

WHEREAS, Assignor is the exclusive owner of U.S. Ser. No. 88/932,609 (the "Application") for the mark NC DINOS;

WHEREAS, Assignee is desirous of acquiring all of Assignor's right, title, and interest in and to the Mark and the Application, and Assignor is desirous of assigning to Assignee all of Assignor's right, title, and interest in and to the Mark and the Application.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all of Assignor's right, title, and interest in and to the Mark and the Application, together with the goodwill of the business symbolized by the Mark and the Application, and all rights to damages and profits, due or accrued, arising out of past infringements of said Mark and Application, and the right to sue for and recover the same. Assignor hereby assigns to Assignee the entire business or portion thereof to which the associated Mark and Application being transferred pertains.

Assignor shall promptly, upon the request of Assignee, execute such other documents and/or instruments of assignment, transfer and conveyance as Assignee may reasonably request to permit Assignee to record the assignment made by this instrument or any other documents Assignee may reasonably deem necessary or advisable to effectuate the terms and intent of this Assignment.
