TRADEMARK RELEASE AND REASSIGNMENT

This **TRADEMARK RELEASE AND REASSIGNMENT** is made as of May 31, 2023, by **AB PRIVATE CREDIT INVESTORS LLC**, as collateral agent for the Secured Parties (in such capacity, "Collateral Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, **FATBEAM, LLC**, a Washington limited liability company (the "Grantor") and Collateral Agent were parties to that certain Trademark Security Agreement dated as of February 22, 2021 (the "Security Agreement") pursuant to which Grantor granted to Collateral Agent a security interest in and continuing lien on certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Collateral Agent, including the Trademarks set forth on Annex A hereto;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on February 22, 2021, at Reel 7199, Frame 0209;

WHEREAS, Grantor has requested that Collateral Agent release its security interest in and lien on the Trademarks and Trademark Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Collateral Agent's security interest in and lien on the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby releases its security interest in and lien on all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) all of Grantor's Trademarks including those referred to on Annex A attached hereto, including all of the goodwill of the business connected with the use of and symbolized by the foregoing and all extensions or renewals of any of the foregoing; and

(ii) all products and Proceeds of the foregoing, including the right to sue for past, present and future infringement or dilution of any Trademark or for any injury to such goodwill and claims, damages, and proceeds of suit.

2. Collateral Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in and to the Trademarks and the Trademark Collateral.
