## **TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**, dated as of June 7, 2023 (this "Release"), is made by PLATFORM COLLATERAL SERVICES, LLC, a Colorado limited liability company, as Collateral Agent (the "Collateral Agent"), in favor of FINSTRO HOLDINGS PTY LTD ACN 605 121 364, an Australian proprietary limited company (the "Grantor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of April 12, 2023 (as amended or modified from time to time, the "Security Agreement"), between the Grantor and the Collateral Agent, the Grantor granted to the Collateral Agent, for the ratable benefit of the Noteholders, a continuing security interest in Grantor's right, title and interest in and to the Trademark Collateral, including the trademark registrations and trademark applications listed on Schedule A attached hereto; and

**WHEREAS**, the Security Agreement was recorded at the United States Patent and Trademark Office (the "USPTO") on April 21, 2023 at Reel 8048 Frame 0299 (the "Notice").

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Noteholders, and the Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the Notice.

**SECTION 2. Termination and Release.**

- 1) The Collateral Agent, without representation, warranty, or recourse, hereby terminates, cancels, discharges, and releases the continuing security interest in the Trademark Collateral; and
- 2) The Collateral Agent hereby authorizes the recordation of this Release with the USPTO at the Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**IN WITNESS WHEREOF**, the Collateral Agent, on behalf of the Noteholders, has caused this Release to be duly executed as of the date first set forth above.
