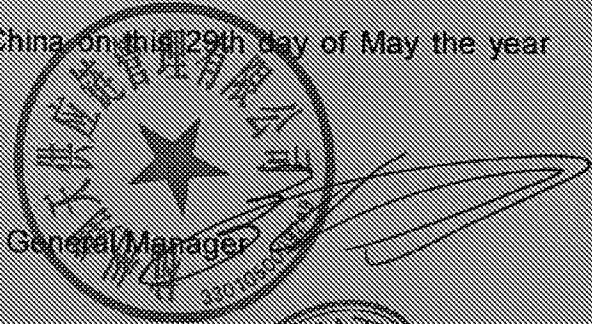
Trademark assignment
