RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Trademark Release"), dated as of June 13, 2023, is made by Bank of Montreal in favor of Detection USA Inc. ("Grantor").

WITNESSETH:

WHEREAS, Grantor has executed and delivered (a) that certain Letter Agreement dated as of November 20, 2013, between, *inter alia*, Grantor, as US Borrower, and Bank of Montreal, as Canadian Lender (the "Letter Agreement") and (b) that certain Grant of Security Interest in Trademarks, dated as of November 20, 2013 (the "Trademark Security Grant") in favor of Bank of Montreal, pursuant to which Grantor granted to Bank of Montreal, a security interest in and to all of its rights, title and interest in the Trademark Collateral (as defined in the Trademark Security Grant) and which Trademark Security Grant was recorded with the United States Patents and Trademark Office ("USPTO") on November 25, 2013 at Reel/Frame No. 5160/0401;


WHEREAS, pursuant to that certain Payout and Release, dated as of December 22, 2021, by Bank of Montreal to, *inter alia*, Grantor (the "Payout and Release"), Bank of Montreal has released the security interest in and to the Trademarks Collateral, including the Trademarks listed on Schedule I hereto (collectively, the "Released Collateral");

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Grantor and Bank of Montreal agree as follows:

1. Termination and Release. Bank of Montreal, on its own behalf and on behalf of the Security Parties (as defined in the Letter Agreement), hereby (a) releases, terminates, forever discharges, and cancels, without any representation or warranty, any and all liens and security interests it may have in and to the Released Collateral.
2. Recordation. Bank of Montreal hereby authorizes the Grantor and its designees to record this Trademark Release with the USPTO or any other applicable governmental authority at the Grantor's expense.
3. Further Assurances. Bank of Montreal, at the Grantors' expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein.
