RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of June 16, 2023, by Oaktree Fund Administration, LLC as agent (in such capacity, together with its successors and permitted assigns, the “**Administrative Agent**”) for the Lenders (as defined in the Loan and Security Agreement), in favor of Sunland Asphalt & Construction, LLC (the “**Grantor**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Trademark Security Agreement (as defined below).

WHEREAS, the Grantor and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of January 13, 2021 (the “**Trademark Security Agreement**”), whereby the Grantor granted to the Administrative Agent, for the ratable benefit of the Lenders, a security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral, including those United States Trademarks listed on Schedule I attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“**USPTO**”) on January 14, 2021 at Reel/Frame 7162/0042; and

WHEREAS, the Grantor has requested that the Administrative Agent execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral for filing and recordation with the USPTO.


NOW THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without any representation, warranty or recourse of any kind or nature, hereby (i) terminates and cancels the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the security interest in the Trademark Collateral, and (iii) re-transfers, re-assigns and re-conveys to the Grantor any and all right, title or interest the Administrative Agent may have in, to or under the Trademark Collateral pursuant to the Loan and Security Agreement or Trademark Security Agreement.

THIS RELEASE SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
