**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of June 21, 2023, by **JPMORGAN CHASE BANK, N.A.**, in its capacity as Lender (the “Lender”) pursuant to the Credit Agreement, dated as of July 19, 2021 (as amended, amended and restated, supplemented, restructured or otherwise modified, renewed or replaced from time to time prior to the date hereof), between, the Lender, Empower Clinic Services, L.L.C. Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Lender, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Lender, in all of its right, title and interest in and to the Trademarks, including without limitation the Trademarks listed in **Schedule A**.


WHEREAS, the Lender has agreed to terminate and release the Security Interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Lender hereby releases, terminates, cancels and discharges any and all of its interest in the Trademarks of the Grantor, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest, and authorizes the recordation of this Release with the United States Patent and Trademark Office at Grantor’s expense, to the extent applicable.
