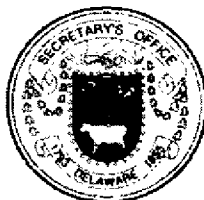

FIRST: The name of the surviving corporation is American Cricket Enterprises Inc., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is American Cricket Enterprises Inc., a California corporation, with California Entity Number C4229086.

SIXTH: The merger is to become effective on September 15, 2021.


SEVENTH: The Agreement and Plan of Merger is on file at First Street, Suite 7, Los Altos, California 94022, an office of the surviving corporation.
