**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Intellectual Property Security Agreement (this “**Release**”) is made with regard to that certain Intellectual Property Security Agreement (“**Agreement**”) entered into as of April 21, 2022 by and among **SILICON VALLEY BANK UK LIMITED** (now known as HSBC Innovation Bank Limited), registered in England and Wales at Alphabeta, 14-18 Finsbury Square, London EC2A 1BR, UK (Company Number 12546585), as Agent (“**Agent**”), **LETSGETCHECKED, INC.**, **VERITAS GENETICS INC.**, and **PAULUS HOLDING LIMITED** (individually, a “**Grantor**” and collectively, the “**Grantors**”). Capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Agreement.

WHEREAS, Agent agreed to make certain advances of money and to extend certain financial accommodations to Grantors in the amounts and manner pursuant to the terms of the Loan Agreement and/or the US Guaranty and/or the Irish Guarantee and Indemnity, as applicable, and each Grantor has granted to Agent a security interest in all of such Grantor’s right, title and interest, whether presently existing or hereafter acquired, in, to and under all of such Grantor’s Collateral.

WHEREAS, pursuant to the Loan Agreement and/or the US Guaranty and/or the Irish Guarantee and Indemnity, as applicable, the parties entered into the Agreement which was recorded on April 21, 2022 at Reel 059672 Frame 0114 in the Patent division of the U.S. Patent and Trademark Office, and each Grantor granted Agent a security interest in certain Intellectual Property Collateral, listed in Exhibit B hereto (the “**Patents**”);

WHEREAS, pursuant to the Loan Agreement and/or the US Guaranty and/or the Irish Guarantee and Indemnity, as applicable, the parties entered into the Agreement which was recorded on April 21, 2022 at Reel 7699 Frame 0623 in the Trademark division of the U.S. Patent and Trademark Office, and each Grantor granted Agent a security interest in certain Intellectual Property Collateral, listed in Exhibit C hereto (the “**Trademarks**”);

WHEREAS, the Grantors have paid and satisfied in full the Obligations under the Loan Agreement and/or the US Guaranty and/or the Irish Guarantee and Indemnity, as applicable, and the parties desire to enter into this Release to confirm that Agent has released its security interests in and to the Intellectual Property Collateral and to expunge any recordation of the Security Interest insofar as it pertains to the Intellectual Property Collateral.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent forever releases and discharges the entire Security Interest in and to all of the Intellectual Property Collateral, including the Trademarks, Trademark applications, Patents, Patent applications, Copyrights, and Mask Works, granted to Agent by the Agreement, and with respect to the Trademarks, such release shall include the goodwill of the business connected with the use of, and symbolized by, each such Trademark, and terminates the Agreement.

Agent hereby agrees to execute such instruments, to take such other actions, and to give such further assurances as Grantors reasonably shall request to terminate any security interest in the Intellectual Property Collateral pursuant to the Agreement and otherwise to effectuate the release of all recordations of such Security Interest in the Intellectual Property Collateral. Agent hereby authorizes each Grantor to record this Release with the U.S. Patent and Trademark Office.

Agent acknowledges and agrees that the Grantors and its successors and assigns may rely upon this Release. Agent represents and warrants that it has not transferred or assigned all or any part of the Security

Interest in the Intellectual Property Collateral to any third party, and that it has all necessary authority to execute this Release and grant the releases and discharges and all other rights set forth herein.
