RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of this 30th day of June, 2023, by PNC BANK, NATIONAL ASSOCIATION, as Agent for the Lenders ("Agent"), in favor of WHC, LLC, a Louisiana limited liability company ("Grantor").

WITNESSETH

WHEREAS, Grantor, certain affiliates of Grantor from time to time party thereto, Agent and the other lenders from time to time party thereto (collectively, the "Lenders") have entered into that certain Revolving Credit and Security Agreement dated as of October 15, 2019 (as the same may be amended, restated, supplemented and/or otherwise modified from time to time, the "Credit Agreement"), providing for extensions of credit to be made to the Borrowers thereunder by Agent and the Lenders;

WHEREAS, Grantor and Agent have entered into that certain Trademark Security Agreement, dated as of October 15, 2019 (the "Trademark Security Agreement"), in favor of Agent pursuant to the terms and conditions of the Credit Agreement, where Grantor granted to Agent a continuing security interest in the Trademark Collateral, including, without limitation, the trademark registrations listed on Schedule A attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on October 15, 2019, at Reel/Frame 6771/0497; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Agent.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Agent hereby (i) terminates the Trademark Security Agreement and (ii) terminates, cancels, releases (and reassigns to Grantor, as applicable) any and all liens and

security interests granted in the Trademark Collateral, including without limitation, the trademark registrations listed on Schedule A attached hereto. Agent (i) shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release and (ii) Agent hereby authorizes and requests the Commissioner of Trademarks at the PTO to record this Release. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Trademark Security Agreement.
