## TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") effective as of 6/10/23 ("Effective Date"), by and between **El Nopalito Meat Co. LLC, a California Limited Liability Company** (the "Assignor") and **El Nopalito, Inc.** (the "Assignee"). Each of Assignor and Assignees are referred to herein as a "Party" and collectively as the "Parties."

WHEREAS, Assignor has adopted, and is the owner of the **EL NOPALITO** word mark as identified in U.S. Registration no. 6635277, and incorporated herein by this reference, and all other rights appurtenant thereto, including, but not limited to, all common law rights, trade name rights, causes of action, and the right to recover for past infringement (the "Trademark");

WHEREAS, Assignee is desirous of acquiring all rights, title, and interest in and to the Trademark owned by Assignor; and

WHEREAS, Assignor is willing to assign to Assignee all rights, title, and interest as Assignor possess in and to the Trademark;

NOW, THEREFORE, for good and adequate consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereby agree as follows:

1. **Conveyance.** Assignor does hereby assign, transfer and convey to Assignee any and all rights, title, and interest as Assignor possess in and to the Trademark; together with the goodwill symbolized by said Trademark, the portion of the business associated with and symbolized by the Trademark, and all rights and remedies against past, present, and future infringement or other violation thereof.
2. **Recordation.** Assignee shall have the right to record Assignee as the owner of the assigned Trademark in the United States Patent and Trademark Office and any other applicable foreign Governmental Authority or registrar.
3. **Further Assurances.** Assignor shall, from time to time, at the request of Assignee and at Assignee's sole expense, execute and deliver such other instruments of conveyance and transfer (including powers of attorney) as are reasonably required by Assignee to effect, register or maintain the Trademark.
4. **Counterparts.** This Assignment may be executed in counterparts, each of which shall be deemed to be an original, but all of which, taken together, shall constitute one and the same
