**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 30, 2023 (this “*Release*”), is made by Cortland Capital Market Services LLC, as administrative agent for the Secured Parties (the “*Administrative Agent*”) in favor of Monitronics Security, LP, a Delaware limited partnership (“*Grantor*”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of August 30, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*Security Agreement*”) among the Grantors and Administrative Agent, the Grantors granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all of the Grantors’ right, title and interest in and to all their right, title and interest in, to and under the Trademark Collateral; and

**WHEREAS**, pursuant to the Security Agreement, the Grantors executed and delivered to Administrative Agent a Notice of Grant of Security Interest in Trademarks, dated as June 15, 2021, between the Grantors and Administrative Agent (the “*TMSA*”), which was recorded in the records of the United States Patent and Trademark Office on June 24, 2021 at reel 7335, frame 0273.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and the Grantors agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or the TMSA, as applicable.

**SECTION 2. Termination and Release.** The Administrative Agent, on behalf of itself and the other Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of the Grantors’ right, title and interest in and to all their right, title and interest in, to and under the Trademark Collateral, including, but not limited to, the Trademarks and Trademark applications listed on Schedule I attached hereto, granted pursuant to the Security Agreement and the TMSA; and


(b) authorizes the recordation of this Release with the United States Patent and Trademark Office at the Grantors’ expense, to the extent applicable.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.
