## DEED OF ASSIGNMENT

This Assignment is made the 30 day of June 2023

### BETWEEN:

1. Bright Concord Investment Limited of Vistra Corporate Services Centre, Wickhams Cay II, Road Town, Tortola, VG 1110, British Virgin Islands (the "Assignor")
2. The Assignor and Assignee are parties to that certain Asset Purchase and Assignment Agreement, dated as of June 14, 2023 (the "Purchase Agreement"), pursuant to which Assignor agreed to transfer, sell and convey to Assignee certain of the assets of Assignor, including the Trade Marks and the goodwill of the business symbolized thereby; and
3. PROXIMA BETA PTE. LIMITED of 10 ANSON ROAD #21-07 INTERNATIONAL PLAZA 079903, SINGAPORE (the "Assignee").

### WHEREAS:

- A. The Assignor is the registered proprietor of the "Trade Marks", details of which are attached at "Schedule 1".
- B. The parties have agreed upon the following assignment:

### AGREED TERMS:

1. For good and valuable consideration paid by the Assignee to the Assignor (the receipt of which the Assignor acknowledges), the Assignor assigns to the Assignee absolutely all property, right, title and interest in and to the Trade Marks together with the goodwill in the Trade Marks (but no other goodwill whatsoever) and together with all rights of action, powers and benefits belonging or accrued to the same including the right to claim and recover relief in respect of all infringements of the Trade Mark arising prior to the date hereof.
2. The Assignor will at the request of the Assignee execute and sign all such instruments, applications and documents and do all such other acts and things as may reasonably be required by the Assignee to give effect to the terms of this assignment and to ensure that the Trade Mark vests in the Assignee.
3. To the extent that any provision of this Assignment is found by any court or competent authority to be invalid, unlawful or unenforceable in any jurisdiction that provision shall be deemed not to be a part of this Assignment but it shall not affect the enforceability of the remainder of this Assignment nor shall it affect the validity, lawfulness or enforceability of

that provision in any other jurisdiction and shall continue to be valid as to its other provisions and the remainder of the affected provision.

4. This Assignment may be executed by the parties on separate counterparts but shall not be effective until each party has executed at least one counterpart. Each counterpart when executed shall be an original and all counterparts shall together constitute one Assignment.
  
5. This Assignment and any dispute, claim or obligation (whether contractual or non-contractual) arising out of or in connection with it, its subject matter or formation shall be governed by Hong Kong law. The parties irrevocably agree that any dispute or claim (whether contractual or non-contractual) arising out of or in connection with this Agreement, its subject matter or formation shall be submitted to arbitration at Hong Kong International Arbitration Centre (the "HKIAC") in accordance with the HKIAC Arbitration Rules in effect.
