TRADEMARK ASSIGNMENT AGREEMENT

This agreement is effective *nunc pro tunc* as of December 6, 2018 (the "Effective Date") by and between Shenzhen Yi Kai Er Electronics Co., Ltd, a Chinese corporation with as address of 5th floor, 404 Yu An 2nd Road, Bao'an, Shenzhen 518133, China ("Assignor") and iTronics Co., Limited, a Hong Kong corporation with an address of Room 1303 Kai Tak Comm Bldg 317-319, Des Voeux Rd. Central, Hong Kong, China ("Assignee" collectively with Assignor, "the parties"), as the successor in interest to the relevant business of Assignor.

The parties agree that the following is an assignment for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged. The parties agree as follows:

1. On the Effective Date, Assignor transferred to Assignee any rights, title, and interest it may have held in and to the trademark THERMPRO, registered as U.S. Trademark Registration No. 5,096,972 (the "Mark").
2. Assignor hereby *nunc pro tunc* confirms and ratifies the sale, assignment, transfer, conveyance and delivery to Assignee, its successors and permitted assigns, all right, title and interest, in and to the Mark, and all of the goodwill of the business associated with the Mark, together with that portion of Assignor's business to which the Mark pertains, any renewals of the registration, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this agreement had not been made together with all causes of action for any and all previously occurring infringement of the rights being assigned and the right to receive and retain the proceeds relating to those infringements as of the Effective Date, and Assignee hereby *nunc pro tunc* confirms and ratifies its acceptance from Assignor
3. Assignor hereby requests the Commissioner for Trademarks at the United States Patent and Trademark Office (the "Commissioner") to record this agreement.
4. This agreement may be executed in any number of counterparts (including by means of facsimile and electronically transmitted portable document format (pdf) signature pages), each of which shall be an original but all of which together shall constitute one and the same instrument.
5. This agreement shall be binding upon, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.
6. Each of the signers on behalf of the respective parties hereto warrants that he was authorized to sign on behalf of such party as of the Effective Date.

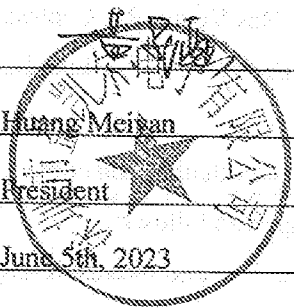
