CONFIRMATORY DEED OF DEBENTURE OF INTELLECTUAL PROPERTY RIGHTS

DATED 19 JULY 2023

BETWEEN THE FOLLOWING PARTIES

- (1) **CRESCENDO BIOLOGICS LIMITED**, a company incorporated in England and Wales under registration number 06425006 whose registered office is at Meditrina Building, Babraham Research Campus, Cambridge, CB22 3AT, United Kingdom (the "**Chargor**"); and
- (2) **KREOS CAPITAL VII (UK) LIMITED**, a company incorporated in England and Wales under registration number 13611522 whose registered office is at 25-28 Old Burlington Street, London, W1S 3AN, United Kingdom (the "**Lender**").

The Parties confirm that

- (A) A Debenture was executed by the Parties on 19 July 2023.
- (B) The Lender has agreed, pursuant to a Loan Agreement executed by the Parties on 8 June 2023, to provide the Chargor with a loan facility on a secured basis.
- (C) Under the Debenture, the Chargor provides security to the Lender for the loan facility made available under the Loan Agreement.
- (D) The monies borrowed by the Chargor under the Loan Agreement are secured by Security Interests over the Chargor's Intellectual Property, including registered Intellectual Property as set out in the Schedules in Annex 1 and 2 as attached hereto. Accordingly, the Borrower hereby grants to the Lender, to the extent granted pursuant to the terms of the Debenture, a security interest on the Chargor's Intellectual Property, including registered Intellectual Property as set out in the Schedules in Annex 1 and 2 as attached hereto.
